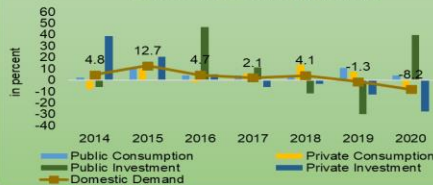

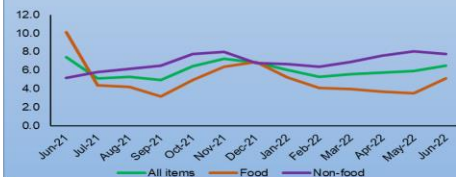
Sectoral Share of GDP-Production



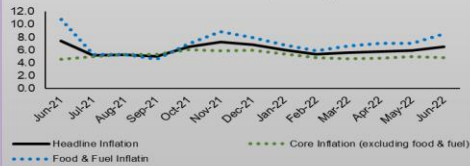
Domestic Demand Growth

Core Inflation (Y-o-Y)

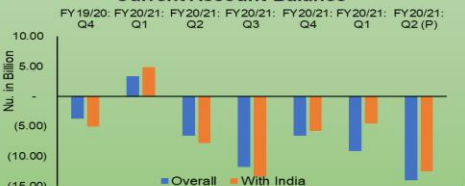

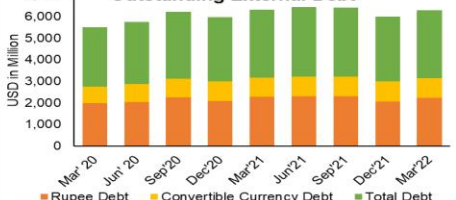

Growth in M2 & its Counterparts

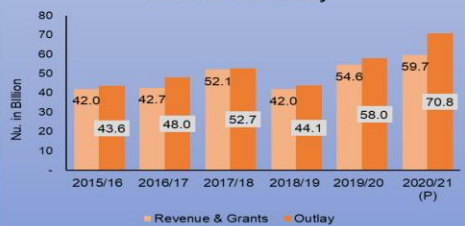

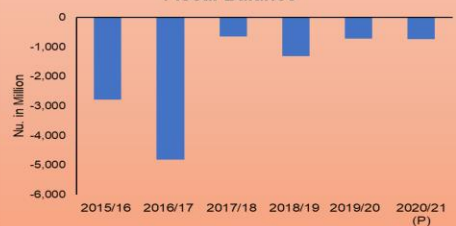
Revenue and Outlay
